KEY POINTS OF THE REGULATION:

- ▶ The term "Data Quality" is anchored in law

- ▶ Data no longer relevant to the original purposes for processing must be fully erased ("Right to be Forgotten")
- ▶ Customers have a comprehensive and free right of access to all information concerning them



IN THE EVENT OF NON-COMPLIANCE:

- ▶ Data processors and other responsible persons in organisations can be held personally liable
- ▶ Fines of up to €20 million or 4% of annual global turnover (whichever is greater) are possible
- ▶ Expansion of the assessment basis to include turnover (not capped)

The new EU General Data Protection Regulation (GDPR) will come into force on 25 May 2018, and considerably increase the rights of consumers for informational self-determination, as well as significantly restricting the possibilities of companies and other organizations for processing personal data. Also, the actual processing of such data will be subject to rigorous constraints.

Companies will have to provide their customers with comprehensive information about the type, reason and extent of their partial or complete processing of personal data. The customer will have a comprehensive and free right of access to his or her personal data. This means that companies must

be able to provide their customers with information about all collected data relating to them in an easily understandable and structured form.

However, the processes and systems in many companies are simply not designed to provide such information. Personal customer data is stored in silos, and is incomplete, inconsistent and contains many duplicates. The full extent of the need for action is not clear, and concrete improvement measures can only be determined and implemented with great difficulty.
